CATEGORIES OF MEMBERSHIP AND ELIGIBILITY

Ordinary Member

Ordinary membership shall be open to any business entity which shall meet the following requirements.

- a. Have a significant activity in the security systems business, the installation and servicing of security systems.
- b. Have been in the activity described above for a period of not less than three years
- c. Obtained BCA registration of L.3 and above or:
Have an annual turnover of not less than S\$3m over the past two years prior to application.

2 ordinary members shall sponsor the applicant for admission to the grade of ordinary member.

Associate Member

Associate Membership shall be open to any business of manufacturing, distributing, supplying, dealing in or selling products or services generally used and relating to and necessary to the members of the Association.

Associate members shall have voting rights. They may, when invited by the association, participate in meetings, convention, exhibitions and other activities organised or arranged by the association. One representative among the Associate Members shall be selected to hold office, except for the position of President.

2 Ordinary members shall sponsor the applicant for admission to the grade of associate member.

Individual Member

Individual membership shall be open to any individual individual who add prestige to or advance the interests of the association and security in general.

Associate members shall have voting rights. They may, when invited by the association, participate in meetings, convention, exhibitions and other activities organised or arranged by the association. One representative among the Associate Members shall be selected to hold office, except for the position of President.
